[When you use Network Camera Recorder BB-HNP11]

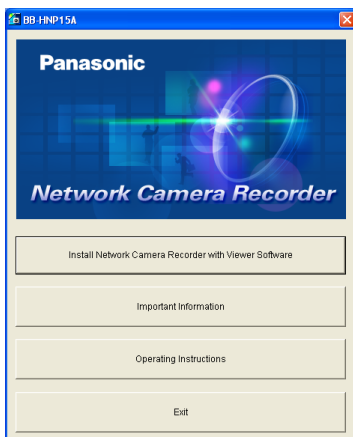
You do not have to uninstall BB-HNP11 when you install this software.

- Installation Selection window automatically appears.



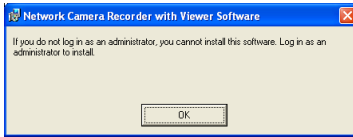

- Adobe® Acrobat® Reader® must be installed on your PC. It can be downloaded from the Adobe website.

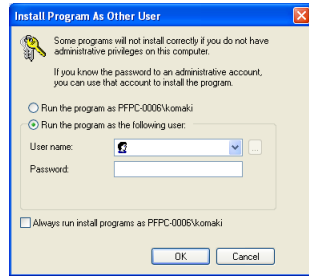
2. Click [Install Network Camera Recorder with Viewer Software].

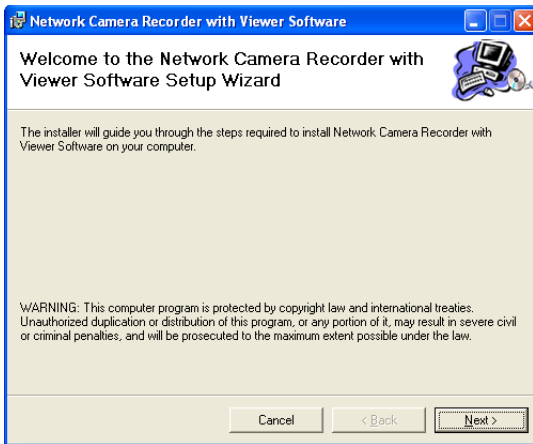
If you do not log in as an administrator account user, you cannot install this software and the following windows will be displayed. Log in as an administrator.



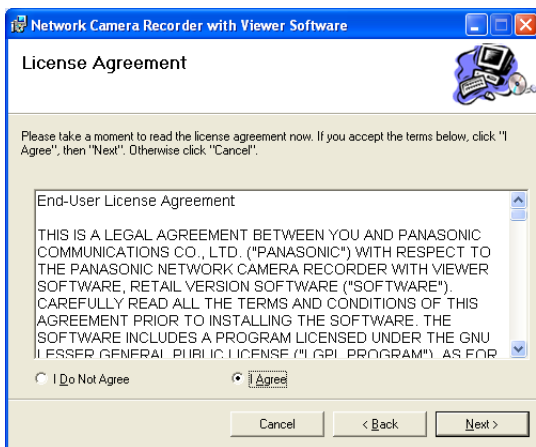

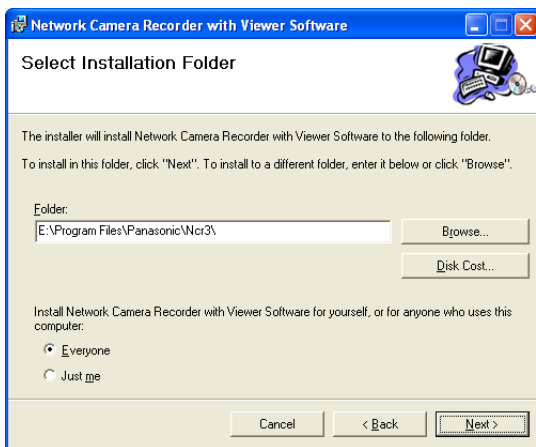
3. Click [Next>].



4. Check [I Agree] and click [Next>].



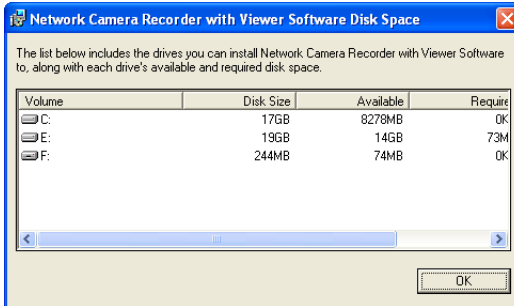
5. Select the destination folder, and click [Next>].



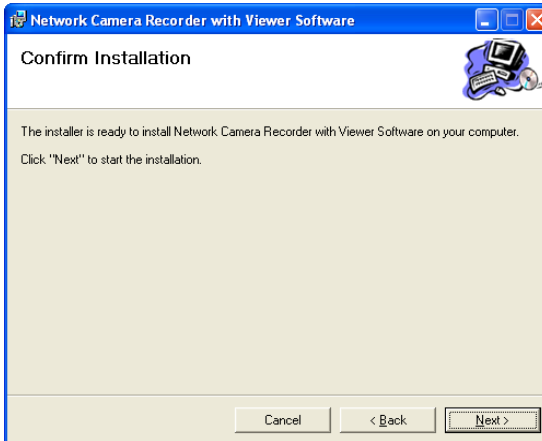
Note

- [Everyone] means users having an administrator account.

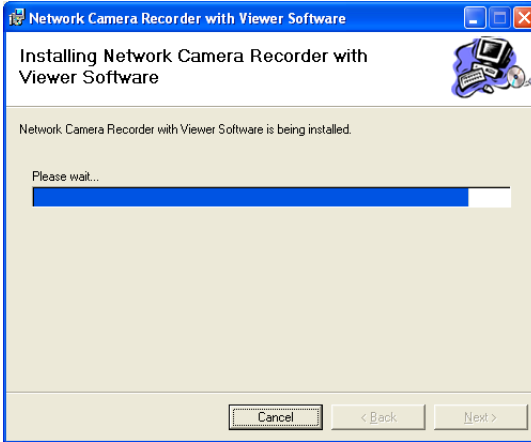
- Click [Browse...] to change the destination folder.

- If you click [Disk Cost...], installable drives, each drive disk size and free capacity are displayed.



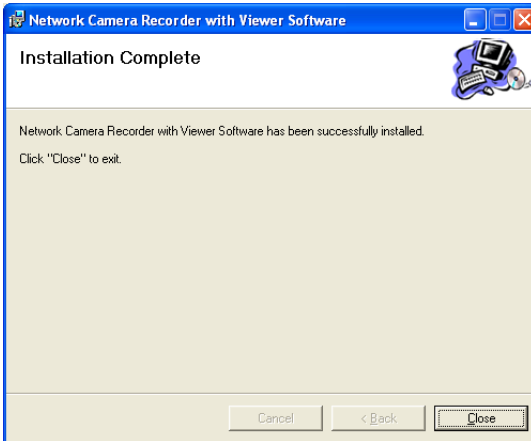
6. Click [Next>].

7. Click [Close].

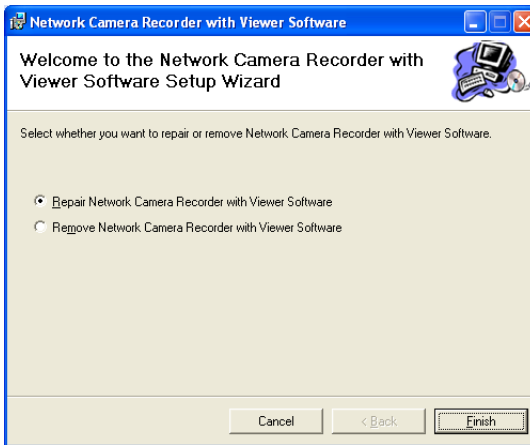

 - If this software have been installed, the following window is displayed.



3. Check [Repair Network Camera Recorder with Viewer Software] or [Remove Network Camera Recorder with Viewer Software], and click [Finish].
 - If the modification or deletion is complete, the confirmation window is displayed.

If you delete this software, the camera settings and recorded images are not deleted. To delete them, manually delete NCR3 folder at the destination.
